

**NOTICE OF A PUBLIC HEARING  
OF THE MIFFLIN COUNTY COMMISSIONERS ON BEHALF OF THE LEWISTOWN BOROUGH COUNCIL  
FOR BUDGET MODIFICATIONS TO THE BOROUGH'S FEDERAL FISCAL YEARS 2015 AND 2017 COMMUNITY  
DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM**

Notice is hereby given that the Mifflin County Commissioners, on behalf of the Lewistown Borough Council will hold a public hearing on **Thursday, March 1, 2018 at 9:15AM** on the second floor, in meeting room A of the Mifflin County Courthouse, located at 20 North Wayne Street, Lewistown, PA 17044. Subsequent to the March 1, 2018 public hearing, the Lewistown Borough Council, will consider adoption of the resolution on **Monday March 12, 2018** at 5:00PM authorizing the County on behalf of the Borough, to submit said modification documentation to PA-DCED for approval. This meeting will be held at the Lewistown Borough Community Center located at 108 Montgomery Avenue, Lewistown, PA 17044. On **Thursday, March 15, 2018** the Mifflin County Commissioners will consider adoption of the resolution approving said modifications.

The purpose of the public hearing is to receive citizens' views, comments and suggestions or other information from the public, for consideration by the Mifflin County Commissioners on behalf of the Lewistown Borough Council, prior to modifying the 2015 and 2017 Borough's CDBG program budgets. Additionally, citizens may also comment on the Borough's prior use of CDBG funds. One hundred (100%) percent of the 2015 and 2017 funds will be used to benefit low and moderate income persons.

The range of activities which may be undertaken with CDBG funds include but are not limited to, benefiting low-moderate income persons through various eligible activities, meeting an urgent need as identified by the community, and preventing and eliminating slum and blight.

The purpose of the modification for the 2015 budget involves the creation and funding of the Grand Parkway North road reconstruction project, in the amount of \$19,188.93, using excess funds remaining from the 2015 Ridge Road road reconstruction project.

The purpose of the modification for the 2017 budget involves the deletion of the Grand Parkway North and Spring Street road reconstruction projects, in the amount of \$14,219.65 and \$85,170.00 respectively and the creation of the Winding Way project funding it in the amount of \$70,520.00 and the creation of the Lombardy Circle to Buena Vista Circle road reconstruction project funding it in the amount of \$28,869.65.

The public is encouraged to attend and participate in the hearing and meeting. Written or oral comments are encouraged and can be directed to James P. Oral comments will be accepted at (717) 242-0887 or at the hearing and meeting. Pursuant to approval by the Lewistown Borough Council and the Mifflin County Commissioners on behalf of the Lewistown Borough Council and after consideration of all comments received by the public, the Mifflin County Planning and Development Department will submit said budget modification documentation to the Pennsylvania Department of Community and Economic Development (PA-DCED) for approval.

The Mifflin County Courthouse building is accessible to handicapped persons.
