# **Borough Council Meeting Minutes**

**July 21st, 2025** 

### LEWISTOWN MUNICIPAL BUILDING COUNCIL CHAMBERS

The Council meeting opened at 4:30 PM with Borough Council President Matthew Moore presiding. The Pledge of Allegiance was recited by all present.

- 3. Law & Ordinance Discussion
  - a. Chapter 24 Amendments: Mr. Barlett shared that these changes to Chapter 24 were properly advertised, as we had discussed at our June Meeting. These will be up for approval later in the meeting.
  - b. Chapter 233 Amendments: Mr. Barlett shared that these changes are for the new parking meters. This will make the parking in the downtown area \$0.50 per hour which is reflected in the Ordinance as \$1.00 per 2 hours on Market Street. Mr. Fink shared that Meters are in production and I anticipate them here within a few weeks.
  - c. Sewer / Refuse Delinquency Timeline: Mr. Fink brought up for discussion the timelines the Borough currently uses for Sewer/Refuse delinquency. These timelines can be long and we will be looking into seeing if there is anything within the Borough Code/Laws to reduce this time to right around a month. Mr. Remy shared the Water Act that Mr. Fink will review and will bring back information at our next meeting.
  - d. Wilson Avenue (Near Green Gables): Codes Department had a request from a resident to make Wilson Avenue to have "No Parking" on one side of the street. They stated that during Softball games they are parking on both sides of the street and it is difficult to pull out of the alley when a game is going on. Mr. Fink said he would work with Codes and see what the best solution would be moving forward.

**Police Chief:** Chief Clemens presented his Police Chief Report for the month of June. Department had 345 Calls for service. 48 Traffic Citations, 38 Non Traffic, 680 parking tickets. He presented his drug report for the month as well. He mentioned that the National Night Out event will take place on Aug 5<sup>th</sup> at Kish Park. The Accreditation Grant Team will be on site on the 12<sup>th</sup> and 13<sup>th</sup>

**Borough Manager:** Mr. Fink updated council on the CCTV progress and mentioned that we would only have 1 meeting in the month of August and it would be on the 18<sup>th</sup> due to Mr. Fink being out of town on 8/4.
